He also reviewed draft design standards and provided transport related risk assessment advice and safety reviews to a wide variety of clients and for a very diverse range of risks.

Tim provides safety and speed management advice and has a particular interest in Workplace Transport Safety. He has provided impartial expert witness evidence in relation to over 50 investigations, notably including the inquest into the death of Diana, Princess of Wales.
